





The Premier League Stadium Fund is working with the Football Association to carry out the assessments of the stadiums used by the clubs that have applied for promotion, in order to ensure their compliance with Grade 7 of The FA Stadium Accreditation Criteria by the 31 March 2026.

The following document will explain in more detail of what the process will look like for you as a club, and what work you will need to carry out between now and the end of the season, as well as answer some of the commonly asked questions.

### What is the Stadium Accreditation Programme?

In 2023, the Premier League Stadium Fund assumed responsibility for the collection of ground grading data for the National League System (NLS), Step 1 to 6.

Up to 996 Clubs are allocated across 48 Leagues of the NLS each season and every stadium that will be used within the pyramid has been assessed through the **Stadium Accreditation Programme** – a programme which was co-designed and developed by the Premier League Stadium Fund (PLSF) and The FA.

Independent PLSF assessors will visit each stadium with the support of leagues and assess them in line with The FA's Stadium Accreditation Criteria to make a recommendation to The FA on whether the stadium meets the level required for each step of the pyramid.

Clubs that are applying for promotion to Step 6 will be subject to the same rigorous assessment as every other club within the NLS and will be given advice and guidance on work they will need to carry out to initially meet Grade 7 during 2025/26, and what further work they would have to complete to meet Grade 6 before the end of the 2026/27 season.

#### What is StadiumPower?

To collect the information consistently and accurately across the country, the Premier League Stadium Fund have designed and built a new bespoke digital tool called **StadiumPower.** 

Historically the data collected under the old process was not held digitally, which would have allowed it to be used for reporting purposes or easily updated.

**StadiumPower** transformed this area of the game, as facilities data is now recorded through a new digital platform across the whole National League System and Women's Football Pyramid for the very first time – with live reporting available for all of the key stakeholders across the pyramid.

#### What are the main requirements of Grade 7?

#### What is required by March 31 2026?

Please read the document in full to understand the requirements, but the key items required include:

- A grass (or FIFA Quality tested 3G pitch) of at least 100m x 64m, in addition to 1.83m run offs on all four sides
- Covered standing accommodation (or covered seating accommodation) for 50 people
- Covered dugouts (containing either 8 seats, or at least 4m of bench seating)
- Hard standing the length & width of at least two interconnected sides of the pitch of at least 0.9m (if new, 1.2m)
- Pitch perimeter barrier, and a safe walkway for players and officials to the changing rooms
- Turnstile (or lockable paybox) with cashier protection
- Two self-contained player changing rooms of at least 12m<sup>2</sup> of clear changing space, and at least one official's room of at least 4m<sup>2</sup>.
- All changing rooms must additionally include their own WC and showers this must be in addition to the 12m2 of clear changing space (or 4m2 of officials changing space).
- Although these are seen as the main requirements, all aspects of the grade set out within The FA Stadium
  Accreditation document must be achieved in order to be compliant. If all requirements are not met by 31
  March 2026, the club will not be eligible to be promoted.

#### What about floodlights?

Floodlights do not need to be in place until September 30 2026.

However, by 31 March 2026 you must be able to demonstrate that you have planning consent for their installation and operation, and the required funds in place. The hours of use of the floodlights must allow for both weekends and night matches.

#### Is there any flexibility on achieving the Grade?

No. We will independently assess the stadium and make a recommendation to The FA on whether it is compliant or not. If the stadium is not fully compliant by 31 March 2026, you will not be awarded Grade 7 which is required for promotion.

#### We previously played in the NLS - does our previous grade count?

No. Every stadium will be assessed independently using StadiumPower

# We currently groundshare with a club (or are a reserve team) that already plays in the NLS, or with a Women's team within the Women's Pyramid - has the stadium already passed?

You will need to speak to the club and ask them if they are compliant, or if they are working towards compliance by 31 March 2026. If they are unsure, please email us.

#### Who will arrange the initial visit?

We will contact you when The FA have reviewed your promotion application, and allocate you an assessor to visit the ground. The assessor will then contact you separately to arrange a suitable date and time to visit the stadium, and we will invite league officials (current league and proposed league) to observe.

#### Who will arrange the revisit?

If you do not meet Grade 7 at the visit, you will have to decide whether you wish to continue your application or advise The FA that you wish to withdraw your application. **The onus is on the club to contact us to arrange the revisit once you believe you have achieved Grade 7.**

#### What should we do ahead of the visit?

You should prepare the stadium as it operates on a matchday and make available all areas of the ground for assessment, such as setting out the secure walkway. Ensure all areas of the ground are available to assess, if we cannot get into the match officials' room because you've not got the keys, it will be recorded as a fail!

#### How long will the visit take?

If it is the first time that the stadium has been visited, please allow up to 3 hours. We collect measurements of all areas of the stadium including its capacity, pitch dimensions and the changing rooms.

#### We applied for promotion in 2023/24 or 2024/25, do we need to be revisited?

Yes, we will want to see if anything has changed since our last visit, but the assessment will take less time to complete.

#### Who can we speak to for guidance during and after the visit?

Your assessor will be able to give you guidance on the day whether the stadium meets the criteria and make suggestions on how to become compliant if you are not. Your StadiumPower report will give you the full analysis.

The Assessor will also be able to give you guidance on the Premier League Stadium Fund and what funding opportunities may exist in the future.

In addition, each Step 6 league has an official that is responsible for facilities who will be able to provide further guidance.

### **FAQ (3)**

#### Can you tell us if any other clubs in our league have achieved compliance?

No, we will not share the grades of other clubs with you

#### We know we have work to carry out. Is there any funding available from the PLSF to help us meet Grade 7?

The Premier League Stadium Fund predominantly funds clubs at Step 1 to 6 of the NLS.

There may be some funding towards certain elements of your stadium, which can be discussed with the Assessor during the visit.

#### Do you fund works at 100%?

If any funding is available, we typically fund works at 70%, so clubs will need to raise the required 30% partnership funding

#### If we are promoted to Step 6, can we get funding then?

Yes, if you are successful in your promotion application we will support you to carry out any works required to meet Grade 6 – typically floodlights and covered seated accommodation.

You will be required to have operational floodlights at Step 6 by September 30 2026 and therefore you can submit an application to us before the 31 March towards these works.

This funding would only be confirmed upon confirmation of promotion from The FA however, if you were unsuccessful, the offer would be withdrawn.

#### If we fail the assessment, can we move to another ground?

No. Your assessment is based on the stadium listed within your application to The FA. You cannot move grounds in order to achieve promotion – you must meet Grade 7 in the stadium that you have played all your games at during the 2025/26 season.

#### We play on a 3G Pitch – what standard must it meet?

To play in the National League System, you must play on a FIFA Quality or FIFA Quality Pro pitch – that has been tested within the last 12 months. If successful with your promotion application, the pitch will have to be tested annually.

Please note that FA Quality 3G Pitches do not meet the requirement for the NLS – they are only suitable for grassroots football.

#### What can be classed as hard standing?

The hard standing must be at least 0.9m wide, and typically, only the following materials are accepted:

- Tarmac
- Concrete (or well laid concrete paving slabs)

The following materials will not be accepted as hard standing:

- Grass
- 3G carpet
- Anything that is made of loose material or that can become loose (such as stone or compacted gravel)

## What is the timeline for the process?

Action	2025/26 Timeline
Promotion application window	From October 1 until December 31 2025
Club to be provided with a login to StadiumPower	Upon receipt of promotion application
First assessment of stadium completed and StadiumPower reports issued to the club	Between 1 October 2025 and 30 January 2026
Club to advise The FA whether they wish to withdraw their promotion application, or will complete the works	By 31 January 2026
Club complete any works required to meet Grade 7 in full	At any point before 31 March 2026
Clubs email StadiumPower and arrange revisit before the 31 March 2026 if they believe Grade 7 has been achieved	Please request your revisit by 28 February 2026
StadiumPower report to be reissued to the club and leagues confirming whether Grade 7 has been achieved	By 10 April 2026
